6. Committee Updates / Events

Scarecrow Festival, this will be held in conjunction with Clayton-Le-Woods Parish Council this year. Proposing the 3rd weekend in September to hold the competition. Cllr Evans will research ideas for a competition / festival and will be the point of contact for Clayton-Le-Woods Parish Council.

10.CIL Monies

Brothers of Charity has submitted a more detailed proposal for CIL funding and requested £15,000 as a contribution. There was some discussion regarding the project and if the Brothers of Charity as an organisation fit the criteria set out for CIL.

Cllr Yates proposed a grant of £6,000 and this was seconded by Cllr Evans. Cllr P Higham proposed that the grant should be 50% of the request at £7,500. Cllr Bell seconded. Chairperson Newall asked the Council to vote on the proposals.

Following the vote of 5 for a grant of £6,000 and 3 for a grant of £7,500 it was agreed that the Brothers of Charity would be offered a grant of £6,000 provided that all the CIL criteria could be met, and full funding secured for the project. Cllr Woods raised the question of how / who would the additional funding be secured. It was agreed that the Brothers of Charity would be requested to show evidence of the project progress and completion.
